Back Ground

1994-1999 – Fraser Watershed Agreement

1994 – FRAFS established to facilitate communication

1999-2007 – series of initiatives to maintain FRAFS despite no Watershed Agreement

- 2008 Forum process initiated
- 2009-2012 Road Map Workshops

Letter of Understanding between FNs and DFO

Committing to prepare for & enter into negotiations

2014 – FSMC formed

• Formalized Constitution & Bylaws, hired negotiator

2016 – Negotiations Commence
Mandate obtained from Signatory Nations
DFO-FSMC negotiations start

2019 - Fraser Salmon Collaborative Management Agreement Signed


provides a framework for co-management of Fraser River salmon between DFO and the Fraser Salmon Management Council (FSMC), on behalf of signatory First Nations

2019-2020 - Implementation work begins

2020-2022 – Process took time and a lot of experienced board members on both sides committed to collaboration to gain momentum to dig deep into the issues and find solutions

2022-2024 - Annual work plans developed – consensus decisions reached and the collaborative management agreement starts to gain momentum

FSMCA – Governance Structure



Work Plan

- 1. Chinook Management- Develop Chinook fisheries management measures that achieve identified conservation objectives and provide for priority access for food, social and ceremonial fisheries.
- Sockeye Management Identify a recommended Sockeye escapement plan option(s), management approaches for stocks of concern and support discussions of FSC sharing for First Nations on an annual basis.
- **3. Governance and Process Development** Support implementation of recommendations arising from the 2022 joint governance sessions, developing and finalizing process documents, and Forum renewal
- **4. FSC Access and Allocation** Support discussions of FSC sharing of Fraser salmon for First Nations as part of the long term work and on an annual basis.

Fish Management & Decision Timelines

- For 2023, the FSMC developed a mandate to reduce Chinook FMI to between 10%-12.5%, with action to address FSC priority, improved monitoring, more timely catch reporting and transparency, etc.
- Chinook allocation decisions are currently made by the minister. DFO must therefore develop options or recommendations, instead of decisions, to send to the minister.
- DFO confirmed options for the minister could include a joint recommendation to reduce FMI for 2023, but the final decision would need to be left to the minister.
- DFO also committed to ensuring that FSMC's position was clearly communicated to the minister, that conservation is a shared objective, and that movement was needed re. management measures for 2023/24.
- We know the parties did not agree on the conservation objective for 2023 so DFO had to provide a rationale for the 14% FMI target.

Fish Management & Decision Timelines

In the event that there is a disagreement by either party they must refer to section 4.3 (d) of the CMA. In this case DFO (Minister) must provide written reasons why and must include:

- Technical / management / policy rationale
- How the decision is consistent with Canada's principles and guiding principles
- How the decision is consistent in law
- How the decision furthers the goals of the CMA and conservation of Fraser salmon
- How the decision furthers reconciliation between Canada and Nations
- To these ends DFO provided a letter to the FSMB which addresses these 5 points

Fish Management & Decision Timelines

- Moving forward, FSMB has agreed on the need to set out quantifiable conservation objectives for 2024/25, so the conversation now turns to how that will happen.
- Options could indicate FSMB and FSMC perspectives. FSMC could also submit their own Tier 1 advice to the Minister (without DFO endorsement) re 10-12.5% FMI for 2024, or request a meeting to discuss proposed reductions.
- FSMC/DFO jointly recommending a 2024 IFMP placeholder to establish/fund the necessary technical process in 2023/24 to establish management objective, benchmarks, etc., in time to inform a decision for the 2024/25 IFMP.

The Dispute Resolution Process Focus on 3 areas

- 1. Chinook Management decision making Process clarity Joint decision-making authority vs recommendations
- 2. Priority Access Policy FSC access and allocation provisions
- 3. Technical Conservation objectives, First Nations priority and rationale for changing the current FMI from 15.6% to something lower

Process Development

- 1. Action Tracker mechanism
- 2. IFMP planning timelines & milestones (GANTT chart development): clarifying steps and checkpoints to develop timely annual planning advice.
- 3. Agenda planning subcommittee, document tracking, and archiving system agreement
- 4. Clarifying/coordinating JTC role in advancing FSMB work plan
- 5. Tier 1: FSMC internal process development

Process Development

- 1. Communications protocols: procedures to develop, approve & share joint messaging; communiques, Website, Annual Report, Build on initial 2023 experiments for Forum reporting
- 2. Strat planning: (March 2023 session; subsequent Tier 1 follow up; next Tier 2 is ??)
- 3. Aligning work planning, action tracking to inform the annual report recommendations
