2024 WATERSHED TALK NEWSLETTER UPDATE

Today's issue of the WST contains summary data of the first in-season Fraser River Panel deliberations. This morning the Panel reviewed the run status and pre-season forecasts of Fraser Sockeye, test fishing catches and acoustics summaries, stock identification, water temperatures throughout the Fraser Watershed and discharge/migration passage at Big Bar.

Fraser Panel Weekly Summary for July 12, 2023

Run Status and Pre-Season Forecasts – To date, 22,000 sockeye from the Early Summer management group have passed through Mission (including Pitt, Allouette, and Coquitlam River). The pre-season forecast for the Fraser River is presented in the table below (Table 1).

Test Fisheries and Stock Identification Review- 100 percent of the sockeye caught in test fisheries this week were from the Early Summer management group. The in-river composition of Early Summer sockeye populations includes Chilliwack; Pitt, Allouette, and Coquitlam; and Nadina, Bowron, Gates, Nahatlatch and Taseko Rivers.

Environmental Conditions – Observed discharge at Hope was 4025m³, which is 29% below historical discharge levels. Across the Fraser watershed water temperatures ranged from 1.5°C to 3.3°C warmer than historical means. The forecast in Kamloops and Prince George is for above average air temperatures and little to no precipitation (Prince George anticipates 1mm).

Fish passage and discharge at Big Bar – There have been no upstream migration problems reported at Big Bar - 87 salmon (assumed to be Chinook) were observed 40 km upstream at Churn Creek and 147 salmon were observed below Big Bar at Alfalfa.
